3.	Intimation by member firms, companies of the change (if any) of their representatives to the Secretary General within three days of announcement of the election schedule.	14-07-2026 (TUESDAY)
4.	Display within seven days of the election schedule, the provisional list of all members eligible to vote alongwith their National Tax Number, Sales Tax Number, the name and National Identity Card Number of the representative: The list shall be displayed at: a) the notice boards of Head office and regional offices; and b) the web site of the trade organization.	21-07-2026 (TUESDAY)
5.	Objections by members (if any) to the entries in the list of voters shall send in writing to the Secretary General within seven days of the issuance of voters list.	28-07-2026 (TUESDAY)
6.	Action and intimation by Secretary General on the objections within five days from the receipt of such objection.	3-08-2026 (MONDAY)
7.	Any person aggrieved by the decision of Secretary General shall make representation within three days to the election commission.	6-08-2026 (THURSDAY)
8.	Decision of election commission on the cases referred to them within three days .	10-08-2026 (MONDAY)

9.	Within three days of decision by the election commission or failure of election commission to decide such cases within stipulated time, any person aggrieved may appeal to the Regulator.	13-08-2026 (THURSDAY)

11.	Display of final list of voters within two days of the decision of Regulator.	26-08-2026 (WEDNESDAY)
12.	If there is no such case is referred to the election commission or to the Regulator, the final list of voters shall be displayed within 15 days of approval of the election commission. The final list shall be displayed at: a) the notice boards of Head office and regional offices; b) the web site of the trade organization; and c) submitted to the Director – General.	28-08-2026 (FRIDAY)
13.	Submission of nomination papers (duly proposed by the registered voter and signed) to the Secretary General within three days of display of final list of voters.	01-09-2026 (TUESDAY)

16.	The objections (if any) shall be filed to the election commission within one day (twenty-four hours) of issuance of the list of contesting candidates.	05-09-2026 (SATURDAY)
17.	Decision by the election commission on such cases within two days .	07-09-2026 (MONDAY)
18.	Filing of appeal to the Regulator within two days by the persons, who are aggrieved by the decision of election commission or it fails to decide such cases within stipulated time.	08-09-2026 (TUESDAY)
19.	Issuance of notice for Annual General Meeting of the Trade Organization.	11-09-2026 (FRIDAY)
20.	Decision of Regulator on such cases within seven (7) days from the date of filing of appeal.	14-09-2026 (MONDAY)
21.	Within one day of the decision of the Regulator the Election Commission shall issue the final list of contesting candidates.	15-09-2026 (TUESDAY)
22.	If there is no such case is referred to the Election Commission or to the Regulator, the final list of contesting candidates shall be issued within 11 days of approval of the Election Commission.	16-09-2026 (WEDNESDAY)

26.	Polling for election of office bearers within two (2) days from the date of issuance of final list of contesting candidates.	26-09-2026 (SATURDAY)
27.	Annual General Meeting for: a) announcement of election results; b) approval of audited accounts; c) appointment of auditors; d) approval of plan of activities for the next year;	30-09-2026 (WEDNESDAY)
